- **Abstract**

As indicated in the whitepaper, the ACA token sale involves the sale of 1,000,000,000 ACA tokens. All processes (with the exception of the Private Sale) are conducted solely through the official web site. We maintain as much security as possible and use a variety of communication channels to disseminate information and conduct PR.

- **Token sale schedule**

- Private Sale (Apr 15 - June 30)

We will raise funds from investors who interact with us through the site. A total of 160M ACA will be sold, with a 40% bonus given. (224M ACA, including bonus)

Bonus 64,000,000 ACA

Minimum 80 ETH

Maximum 3,000 ETH

Bonus rate : 40%

Start : 15 Apr 2018 11:00 UTC+2

End : 30 June 2018 11:00 UTC+2

- Pre-Token Sale (July 14-July 27)

Conducted through the official site only for those investors who pass KYC and are whitelisted. A total of 100M ACA will be sold, with a 30% bonus given. (130M ACA, including bonus)

Capacity 100,000,000 ACA

Bonus 30,000,000 ACA

Minimum 30 ETH

Maximum 1,500 ETH

Bonus rate : 30%

Start 14 July 2018 11:00 UTC+2

End 27 July 2018 11:00 UTC+2

- Public Token Sale (Aug 4-Sep 30)

Conducted through the official site only for those investors who pass KYC and are whitelisted. A total of 586M ACA will be sold. The amount of bonuses differs for each stage. (646M ACA, including bonuses, across all stages)

Once the ACA tokens allocated to a stage sell out, irrespective of timing, the bonuses for that stage will conclude.

Minimum 0.1 ETH

Maximum 500 ETH

- Stage 1(Aug 4-Aug 17)

Total of 200M ACA with 20% bonus. (240M ACA, including bonus)

- Stage 2(Aug 25-Sep 7)

Total of 200M ACA with 10% bonus. (220M ACA, including bonus)

- Stage 3(Sep15-Sep 30)

Total of 186M ACA with 0% bonus. (186M ACA)

*Unsold ACA tokens for each stage of the Private Sale, Pre-Sale, and Public Sale will be carried over to the next stage.

*ACA tokens unsold across all stages will be discarded, excluding bonuses.

*ACA tokens sold during the token sale will be disbursed to a registered ETH wallet address after the token sale ends.

*The exchange rate between ACA tokens and ETH for a round is determined at least 1 day before the start of that round.

*ACA tokens granted cannot be sent until one week prior to the public trading date on more than one exchange.

- KYC (know-your-customer)

Forms and APIs provided by Sub&stance will be used. These processes will be required before purchasing ACA tokens.

- Whitelist

When registering, you must enter your Ethereum wallet address. ACA tokens will only be given per Ethereum you sent through the Ethereum wallet address you registered during this process. If you register the address of an exchange or other address not personally owned by you as an individual, ACA tokens will not be granted.
